## Description

The property is bordered on the south by State Road 337; on the west by a metal fabricator; and on the north and east by farm property. The site is flat, clear, and currently used for agriculture. Additional acreage is available. -Land price is approximately \$10,000 per acre. -Economic Development incentive rates are available to industrial customers which meet minimum demand (500 KW) requirements. -The CSX rail line which serves Orleans has recently been included in the CSX "core" rail system and is not in danger of service reductions or future abandonment.
