Radius Indiana (Owner) is requesting Bids for the fabrication and delivery of Plumbed Restroom Structures for the following Project: Monon South Trail Phase 1B. Vendors are required to complete the enclosed solicitation package and return the bid response via email to: Ryan Hughes, PE of Clark Dietz, Inc., 120 W Spring Street, New Albany, Indiana 47150, PH: 859-286-1141, email: ryan.hughes@clarkdietz.com. Bids will be received electronically until July 17, 2024 at 10:00 AM (Eastern Time). Bids will be opened on or after the Due Date and Time. The bid opening will not be public and will be conducted by a representative of the Owner in the presence of one or more representatives of the Owner.

Plumbed Restroom Structures are to be fabricated for installation at trailheads on the Monon South Trail Project throughout four counties in Southern Indiana. The Structures shall include a complete, functioning two-stall plumbed restroom with a custom-designed façade with cedar planks and black-finished architectural elements to create an overall appearance that fits into the overall design aesthetic of the trail. A three-stall plumbed restroom structure with an office and storage area is also included in the bid package. The restroom structure and all fixtures will be provided as a product/kit from the manufacturer and will be placed on a concrete foundation. The Structures must be provided as complete units produced by a single manufacturer. The basis of design for restroom structures are the products provided in the design drawings, as manufactured by Romtec. Equal products are acceptable provided that they meet the materials, sizes, function, aesthetic details, and other requirements provided in this bid package.

Bids shall include all materials, shipping, and incidentals necessary to deliver a complete product shown on the plans and specifications. A separate project will be advertised for the construction of the trailheads including the installation of the Restroom Structures.
